#### INSTRUCTIONS FOR WRITING ABSTRACTS OR PAPERS

Abstracts should be sent in Serbian and English and papers in English

#### a) Abstracts

Abstracts, using the Latin alphabet, should be written in the program Word for Windows, using the font Times New Roman, size 12pt.

The title is written in small letters, except for the initial letter (avoid abbreviations in the title). The names and surnames of the authors and co-authors are written in a new line. Underline the name of the author who will present the work.

In the next line, indicate the affiliations of the author and co-author (in the case of different institutions, use the marks 1, 2, 3...etc. in the superscript)

The text of the abstract, without titles, authors and affiliations, should not be longer than 250 words. The abstract must have an introduction and aim of the work, methods, results and conclusion (without formally listed sub-headings within the text). In the text, it is not recommended to use tables, graphics and cite references.

Below the text of the abstract, state: full name and surname of the author, place of employment, telephone and electronic address (e-mail).

THE DEADLINE for sending abstracts is May 15, 2024

You will receive notification about the acceptance and method of presenting the work electronically.

### b) Papers

The original manuscript should be (written) printed on A4 paper (210 x 297 mm). The manuscript is limited to 8-10 pages of A4 format, font 10 Arial, including figures, tables, graphs, references and more.

On the pages of the manuscript, the margins should be: top and bottom 3 cm, left and right 2.2 cm. In the middle of the first page of the manuscript, write the title of the paper (in Serbian and English) in size 14 letters (Arial bold).

Below the title, write the author's name (italic) and the name of the institution (also in Serbian and English) (normal) in size 11 letters.

Work to type with spacing 1 (single), font 10, typeface Arial. Subtitles should be written in capital letters, font 10, typeface Arial

#### ABSTRACT

At the beginning of the paper, a short content (usually up to 200 words) should be given in the Summary (in Serbian) and Abstract (in English), as well as keywords in Serbian and English.

INTRODUCTION

MATERIALS AND METHODS

RESULTS AND DISCUSSION

Tables, pictures, graphs, etc. they can be in one or two columns. Above the table should be the name, e.g.

Table 1 - Results of experimental measurements

Below the illustration there should be an explanation, eg: Figure 1 - Process simulation results

Names of tables and graphs are also given in Serbian and English.

This section also compares the results obtained by the authors with the data from the papers listed in the reference list, which is the basis of the discussion.

#### CONCLUSION

#### Acknowledgments

The name and number of the project of the Ministry through which the research presented in the paper was financed is stated.

#### REFERENCES

Literature is cited in the text by the last name of the author and the year of publication: (Petrović, 2019), (Janković, Marković, 2020).

In case there are several authors, only the last name of the first author is mentioned in the text: (Jovanović et al., 2020) or (Johnson et al., 2021).

References in the bibliography are listed in alphabetical order:

Petrović, S. (2019). Protection of water resources, Scientific book, Belgrade, 403 pages.

Smith, G. (2020). Title of the article, Chem. Phys., 65 (4), pp. 19-35.
